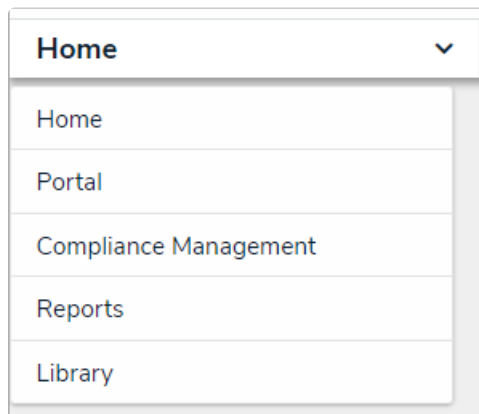

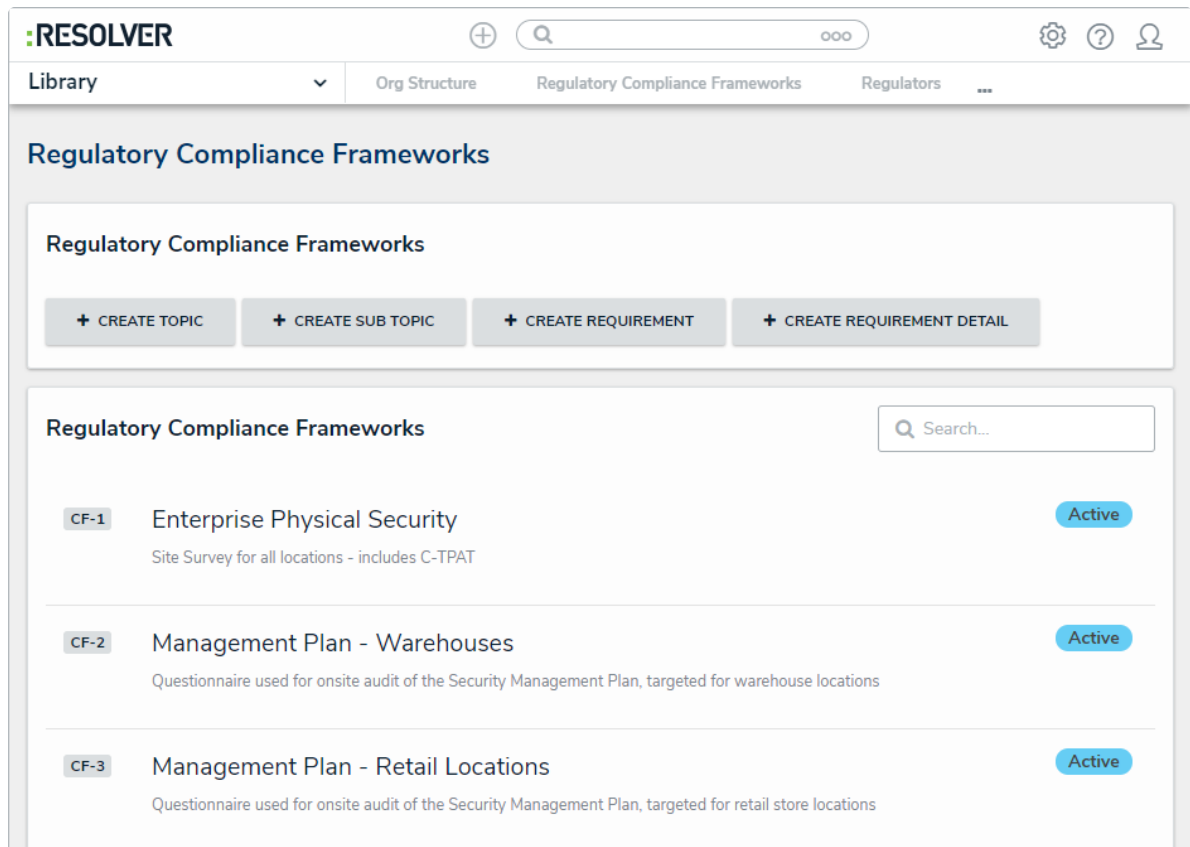
To view your Regulatory Compliance frameworks:

1. Log into a user account that's been added to the **Compliance Team** user group.
2. Click the dropdown in the nav bar > **Library** to display the **Regulatory Compliance Frameworks** activity.

3. Click a framework to open. By default, it will open to the top-most level of the framework hierarchy.
