If Resolver provides your Regulatory Control Framework updates, you will at times need to review updated requirements and their details. As a Compliance Team member, you will be notified via email of updated requirements needing your review.



The following instructions apply only if Resolver is responsible for updating your content.

To view updated requirements:

1. Log into a user account from the **Compliance Team** user group to open the **My Tasks** page.
2. Click a requirement to review or open the nav bar and click **Compliance Management**.
3. From any of the **Compliance Management** activities, click an assessment name from the **In Progress** state to open the review form.

4. In the **Review Regulatory Changes** section:
 - a. Select either **Update All Requirements** or **Review Regulatory Updates Report**.
