

# Creating a Portal URL

## Overview

An Administrator must create a URL Portal before you can allow external and occasional stakeholders access to the **Confidential Portal**.

An Administrator must create a non-administrative user account for the login, and assign it to a [role](#) with access to the appropriate object type(s) and activity before they can create a Portal URL.

## User Account Requirements

The user account you use to log into Resolver must have Administrator permissions.

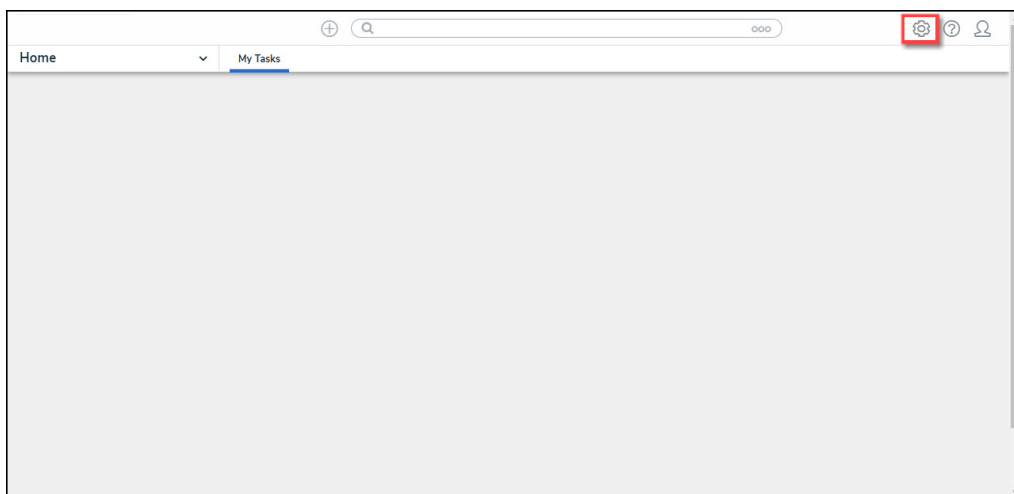

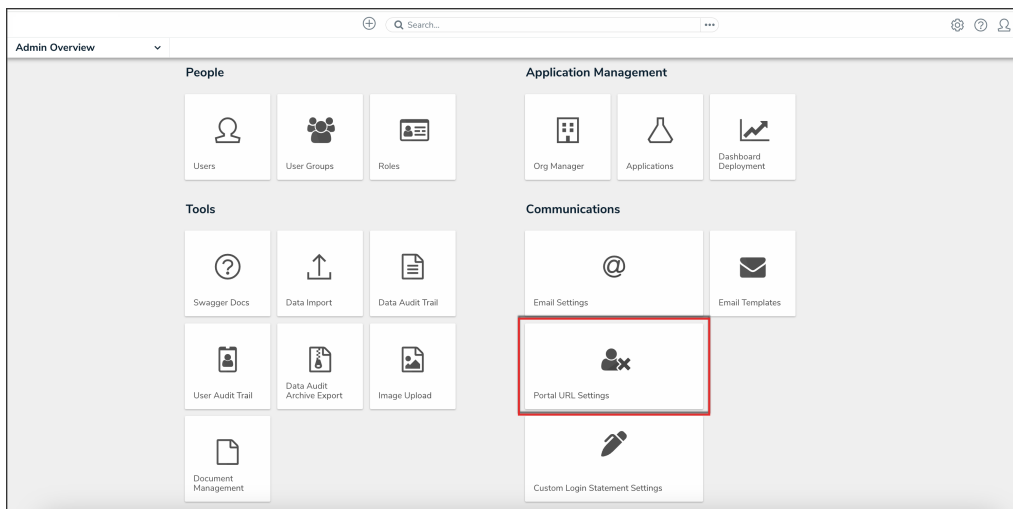

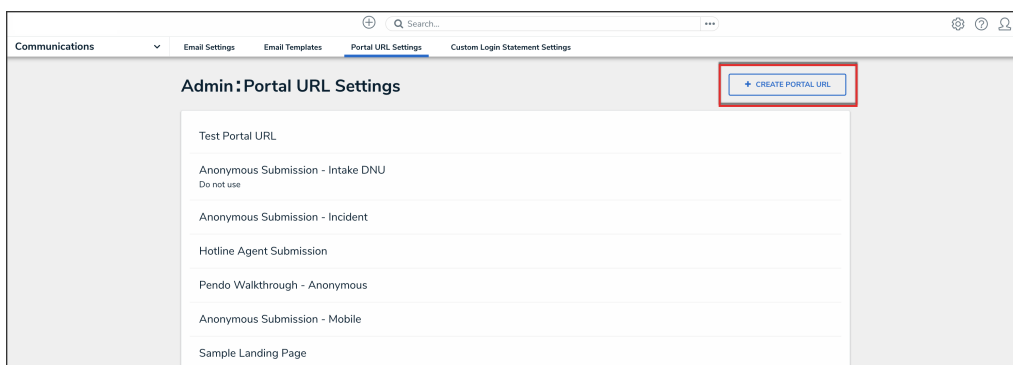

## Create a Portal URL

  - **Application:** Select an **Application** (e.g., IT Risk Management) from the **Application** dropdown list. The **Application** dictates which Activities will be available to select on the **Activity** dropdown menu.
  - **Activity:** Select an **Activity** from the **Activity** dropdown menu. An Activity is the part of an application where users can create, edit, and view data. The **Activity** selected will appear when accessing the Confidential Portal.
